The payment of the Distribution shall be made in US dollars, except that payment to shareholders whose names appear on the register of members in Hong Kong shall be paid in Hong Kong dollars. The relevant exchange rate shall be the opening buying rate of HK\$ to US\$ as announced by the Hong Kong Association of Banks (www.hkab.org.hk) on the day of the approval of the Distribution, i.e., June 5, 2014 (US\$1 = HK\$7.7225). Accordingly, the amount of cash distribution payable in Hong Kong dollars will be approximately HK\$0.4386 per share.
